HIGHLIGHTS

On January 26, the State Intellectual Property Office (SIPO) issued the Decision on Granting the 10th Chinese Patent Award, honoring 15 patents with Chinese Patent Gold Medal and 144 patents with Chinese Patent Award of Excellence.

On February 4, SIPO issued the Special Campaign for the IPR Enforcement of Thunderstorm and Skynet, making a decisive move on IPR enforcement.

From March 3 to 8, SIPO, together with National Copyright Administration of China (NCAC) and State Administration for Industry and Commerce (SAIC), attended the inaugural session of the Committee on Development and Intellectual Property (CDIP) under the World Intellectual Property Organization (WIPO) at the organization's headquarters in Geneva, Switzerland.

On March 21, the State Council issued Circular of the State Council on Organizational Structure of Coordinating Agencies, disbanding the Leading Group of the Formulation of the National Intellectual Property Strategy and National Working Group of Intellectual Property Protection and shifting their duties to SIPO.

In March and October, Chinese delegation composed of SIPO, NCAC, Permanent Mission of China to the United Nations and its Organizations in Geneva attended the 12th and 13th sessions of the WIPO Intergovernmental Committee on Intellectual Property and Genetic Resources, Traditional Knowledge and Folklore (IGC).

On April 9, the State Council reviewed and approved in principle the Outline of the National Intellectual Property Strategy in an executive meeting.

From April 15 to 17, SIPO, using the Asia Regional Cooperation Fund sponsored by the Chinese government, organized Senior Seminar on Asia



Regional Intellectual Property System in Beijing.

On April 18, SIPO and the Organizing Committee of the Chongqing High Tech Trade Fair jointly organized the International Seminar on IP Strategy and Corporate Competitiveness in Chongqing.

On April 26, in the days before and after the eighth World IP Day, SIPO organized a series of activities and celebrations: organizing 2007 Press Conference on China IP Protection, jointly with the State Council Information

Office, SAIC and NCAC; organizing 2008 Press Conference on IP Protection Publicity Week, jointly with 18 members of its organizing committee; organizing the first roving exhibition of excellent paintings or calligraphy on IP culture by a hundred celebrated Chinese artists; participating in Shanghai IP Protection Summit Forum and IP Criminal Protection Forum; conducting SIPO open day; organizing patent information press release and press conference on patented technology marketing; and Roundtable on IP and 30th Anniversary of Reform and Opening-up, jointly with SAIC and NCAC.

From April 30 to May 12, SIPO led a delegation to attend the Paris International Inventions Exposition in Paris, France.

From May 8 to 9, SIPO and WIPO jointly organized the Second Symposium for Heads of Intellectual Property Academies, with the assistance of the China Intellectual Property Training Center (CIPTC) in Beijing.

On May 12, after the great earthquake of 8.0 Richter scale in Wenchuan, Sichuan, SIPO responded swiftly with active measures to join rescue and relief. During the difficult times, WIPO, Office for Harmonization in the Internal Market (OHIM), Italian Patent and Trademark Office, Intellectual Property Organization of Pakistan, International Association for the Protection

of Intellectual Property (AIPPI) Japan sent their support letters or donations, bringing their deep condolences to the people suffering from the devastating earthquake in Sichuan.

From May 13 to 14, SIPO led a delegation to attend the WIPO Coordination Committee meeting, during which Francis Gurry was elected as new Director General of WIPO.

From May 19 to 23, SIPO attended Deputy Heads Meeting of SIPO, United States Patent and Trademark Office (USPTO), European Patent Office (EPO), Japan Patent Office (JPO) and Korea Intellectual Property Office (KIPO) (IP5) held in the US.

On May 21, SIPO, Ministry of Science and Technology (MOST) and Beijing Municipal Government jointly organized the 11th China (Beijing) International Science and Technology Exposition.

From May 25 to 26, SIPO and the Intellectual Property Office of Mongolia jointly organized the China-Mongolia Intellectual Property Enforcement



throughout the nation and organizing the implementation of the National IP Strategy. A department with the name of Protection and Coordination Department was set up. The International Cooperation Department was also recognized as office for patent and other IPR issues in Hong Kong, Macao and Taiwan. The former Coordination & Administration Department was renamed as Patent Administration Department.

On July 16, SIPO, with the assistance of Beijing Intellectual Property Office, organized Forum on Protection of Olympic IPRs in Beijing.

The July/August edition of British magazine *Managing Intellectual Property* selected Commissioner Tian Lipu as one of the top 50 most influential persons in world IP society for 2008.

On September 3, SIPO, Liaoning Provincial Government and China Council for the Promotion of International Trade (CCPIT), with the assistance of

On October 1, the revised Implementation Measures of Patent Agent Qualification Examination and Patent Agent Qualification Examination Rules came into force.

On October 9, the State Council approved SIPO's Request for Establishing the Mechanism of Inter-ministerial Joint Meetings for the Implementation of the National IP Strategy, agreed SIPO to chair the mechanism. Commissioner Tian Lipu will coordinate senior officials from 28 central agencies. A secretariat, stationed in SIPO, takes charge of the daily operation of the joint meetings.


On November 1, 2008 National Patent Agent Qualification Examination was held in 12 cities with 5,492 participants.
