## China seized 112,700 IP cases in the first 3 quarters of 2014 今年前三季度中国查处侵权假冒案件11.27 顶件

n November 21st, China held a press conference in Beijing, publishing that Chinese government has been taking more efforts to crackdown the infringement in recent years, upgrading IPR protection in the whole country. From January to September, China's relevant authorities investigated 112,700 IPR infringement cases of counterfeiting goods and selling shoddy goods, destroyed 1,938 dens of counterfeiting or shoddy goods. The police tracked down 16,100 criminal cases, and arrested nearly 20,000 suspects. The procuratorates prosecuted 12,200 cases involved 20,000 suspects. The courts have concluded 11,600 cases with effective judgments involving 15,700 criminals.

According to the press conference, there were four characteristics occurred to the fighting against infringement and counterfeiting. Firstly, the authorities focused on improving

the long-term effective mechanism, and the system construction has seen a breakthrough. Secondly, special rectification has been focused and the high-pressure of fighting against infringement and counterfeiting was kept. Thirdly, criminal justice was strengthened and the number of investigated cases has gotten a sharp rise. Finally, channels of interaction and communication have been broadened and the website has been upgraded.

At the conference, officials from the Patent Affairs Administration Department under SIPO introduced the achievements made by China's IP authorities in IP law enforcement. In 2013, China's total administrative law enforcement cases on patents reached to more than 16,000, with a yearly increase of 79.8%. In addition, SIPO also actively launched special operations in the field of e-commerce patent rights enforcement, and especially, local IP offices directly as-

signed to the local e-commerce platform to explore the establishment of long-term mechanism for patent protection in the field of e-commerce. For example, IP offices in Zhejiang, Beijing and some other provinces have established cooperation mechanisms, respectively with e-commerce services such as Alibaba Group (China), Jingdong, Dangdang and others, and organized the law enforcement on infringement and counterfeiting for the complaints.

(by Jiang Xu) 本报讯 11月21日,中国打击侵权假冒工作领导小组办公室在北京召开新闻发布会。据相关负责人介绍,近年来,中国政府在打击侵权假冒方面力度持续加大,保护知识产权的水平不断提升。今年1月至9月,中国各有关行政执法部门共查处侵犯知识产权和制售假冒伪劣商品案件11.27万件,捣毁制假售假窝点1938个,公安机关破获案件1.61万

件,抓获犯罪嫌疑人2万余人;检察机

关起诉案件1.22万件,起诉犯罪嫌疑人近2万人;法院审结案件1.16万件, 生效判决1.57万人。

据介绍,中国今年打击侵权假冒工作具有4个特点:一是注重完善长效机制,制度建设取得突破;二是专项整治重点突出,保持打击高压态势;三是强化刑事司法打击,案件数量大幅攀升;四是拓宽交流互动渠道,改版升级工作网站。

会上,中国国家知识产权局专利 管理司有关负责人介绍了中国知识 产权系统开展执法维权专项行动成 效。2013年,中国知识产权系统专利 行政执法办案总量超过1.6万件,同 比增长79.8%。此外,中国国家知识 产权局还积极开展电子商务领域专 利执法维权专项行动,地方知识产权 局直接入驻当地电商平台指导,探索 建立电子商务领域专利保护长效机 制。浙江、北京等地方知识产权局, 分别与阿里巴巴(中国)、京东、当当 等电子商务服务企业建立合作机制, 组织执法人员现场处理侵权假冒投

# Borrego trademark application was rejected "霸锐"商标注册被驳

ia Motor Corporation (hereinafter referred to as Kia) tried to apply for registration of "Borrego" trademark on buses and other commodities, but was dismissed by Trademark Review and Adjudication Board (hereinafter referred to as TRAB) under National Industry and Commerce Administration of China. Kia then filed a lawsuit against TRAB. Recently, the Court made the judgment to maintain the decision of TRAB.

It is reported that the No. 6301519 application "Borrego" trademark was applied by Kia in September 2007, specified used on Class 12 commodities like passenger cars, trucks and other goods. Kia's "Borrego" car was a new launch of SUV published in January 2008, and was sold in china from July 2008.

Since the questioned trademark was similar to the cited trademark on similar used goods, Trademark Office under the National Administration for Industry and Commerce of China re-

jected the Kia's application. The cited No. 4082010 trademark "BaRui", applied by Chongqing Zongshen Industrial Group Co., Ltd. in May 2004, used on Class 12 motorcycles, mopeds and other commodities, is currently in the period of validity. Kia refused to accept the decision by Trademark Office, then applied for a review to TRAB.

TRAB held that, the questioned trademark "Borrego" and cited trademark "BaRui" are used on similar goods such as cars and motorcycles; the Chinese characters of the two trademarks share the same character "Ba" and "Rui", which constitute similar trademarks; it could easily lead to confusion among consumers. Accordingly, TRAB rejected the trademark registration application.

Kia then filed an administrative lawsuit to the Beijing No.1 Intermediate People's Court. The court held that, the applied trademark is specified used on buses, mini buses and other commodities and the cited trade-

mark is used in motorcycles and other goods, which were similar in function, consumers and constituting similar goods; the two trademarks were read in the same Chinese character. Therefore, the co-existence of the two trademarks would lead to confusion among the relevant public. Accordingly, the court made the above decision.

(by Mao Liguo) 本报讯 韩国起亚自动车株式会社(下称韩国起亚)欲在客车等商品上申请注册"霸锐"商标,被中国国家工商行政管理总局商标评审委员会(下称商评委)予以驳回。韩国起亚不服商评委决定,提起行政诉讼。日前,法院一审判决维持了商评委被诉决定。

据了解,申请商标为第6301519号 "霸锐"商标,由韩国起亚于2007年9月 提出注册申请,指定使用在第12类 客车、卡车等商品上。霸锐汽车是韩 国起亚推出的一款SUV,2008年1月 在韩国正式上市,2008年7月在中国

因认为申请商标与引证商标构成使用在类似商品上的近似商标,中

国国家工商行政管理总局商标局决定驳回申请商标的注册申请。引证商标为第 4082010 号"锐霸"商标,由重庆宗申产业集团有限公司于2004年5月提出注册申请,核定使用在第12类摩托车、机动自行车等商品上,目前该商标处于有效期内。

韩国起亚不服该决定,随后向商评委申请复审。商评委认为,申请商标"霸锐"与引证商标"锐霸"使用的汽车与摩托车等商品属于类似商品,两商标均由"霸"字与"锐"字组成,构成近似商标,二者共存易导致消费者对商品来源产生混淆误认。据此,商评委决定对申请商标的注册申请予以驳回。

韩国起亚随后向北京市第一中

级人民法院提起行政诉讼。法院经审理认为,申请商标指定使用的商品在功能与引证商标核定使用的商品在功能用途、消费对象等方面相近,构成类似商品。申请商标与引证商标构成文字相同,仅是排列顺序不同,而中文汉字有分别从左右起认读的方式,故申请商标与引证商标构成近似商标。因此,申请商标与引证商标样存于市场,会导致相关公众的混淆误认。据此,法院作出上述判决。

After China's Reform and Opening up, the traditional arts revived again, and new works of Cui Xin and other masters won reputation at home and abroad. Cui Xin also brought innovation to the skills. However, in the market-oriented economy era, with longtime design and compli-

Chinese dream of intangible cultural heritage

在北京市东城区一栋普通的居民楼里,北京市非物质文化遗产——北京绢人的第三代传人崔欣在工作台前忙碌着。腿部残疾的北京市工艺美术大师,虽然行动不便,但她的作品却漂洋过海,屡获大奖。崔欣见证了北京绢人从年久失传到再度复苏,而这也是她一直在坚守的"中国\*\*"

绢人艺术历史久远,但到了近 代,失去生存环境的绢人技艺渐渐失 传。上世纪50年代,几位老艺师遍 阅史料,悉心钻研,让久已失传的绢 人艺术重新面世。绢人技艺也因此 打上了独特的北京烙印。当年,崔欣 在师傅杨乃蕙和师祖葛敬安的悉心 指点下,全面掌握了北京绢人的工艺 技法。改革开放后,凝聚了传统塑型 艺术精华的北京绢人再度复苏,崔欣 和师傅们的多个新作在国内外赢得 声誉。2000年,崔欣与师傅杨乃蕙同 时被评为北京市工艺美术大师。然 而,到了市场经济时代,耗时月余、以 十几道繁复工序手工精制的北京绢 人再度陷入困境。

"工业化的批量复制,看似是弘 扬传统艺术,实际上却给北京绢人带 来了毁灭性的打击。"如今,与崔欣同 时代的绢人艺师或过世或退休,固守 前辈技艺的传承人寥寥无几,发掘、 抢救和保护北京绢人技艺成为当务 之急。2014年,北京绢人人选北京市 第四批非遗名录,崔欣也看到了这项



古老技艺传承下去的希望。时代变 迁,崔欣仍然选择了坚守,招收徒弟 并倾力传授生平所学。

把传统的北京绢人艺术发扬光 大,是崔欣最大的梦想。正如崔欣所 说:"每一个灌注了心血的绢人,都有 灵魂。"
