

The BRICs IP Coordinating Team established 金砖国家知识产权协调小组成立

The fourth BRICs IP offices conference was recently held in Rio de Janeiro, Brazil. On the conference, Commissioner of SIPO Shen Changyu held talks with acting director of Brazil's National Institute of Industrial Property (INPI), acting director of Russia's IP Office, director of India's Patent, Industrial design and Trademark Office, director of South Africa's IPR Registration Office.

During the conference, all the parties involved have reviewed the history of cooperation between the BRICs IP offices and held in-depth discussions on further cooperation. Five IP Offices all agreed that resources could be integrated and cooperation could be deepened in the following areas, namely, improving public IP awareness, personnel training, examiner exchanges, acceptance procedure, information service, national and enterprise IP strategy and cooperation international forum. Also, the offices agreed that publications on BRICs IP will be printed to deliver information on IP system and policies. Meanwhile, according to the conference agendas, Russia's IP Office will preside over the next conference.

During the visit, Shen held bilateral talks with acting director of Bra-

zil's National Institute of Industrial Property (INPI), acting director of Russia's IP Office, director of India's Patent, Industrial design and Trademark Office, director of South Africa's IPR Registration Office. Also, Shen visited Huawei Company's agency in Rio de Janeiro and debriefed Huawei's IP layout and overseas business development. Some other representatives joined the talks.

Dating back to 2012, the BRICs IP offices conference was initiated. Up to now, the three-level conference mechanism, namely, director meeting, contacts meeting, project group meeting, were established. The cooperation roadmap for some major fields, including improving public IP awareness, personnel training, examiner exchanges, acceptance procedure, information service, national and enterprise IP strategy and international forum cooperation. 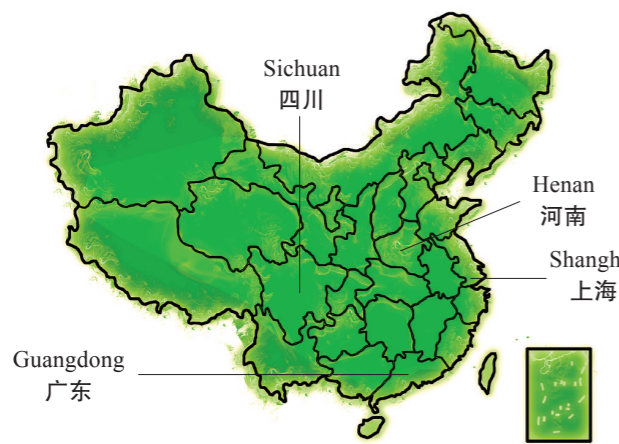

The 4th WIPO Copyright Gold Awards (China) granted 第四届世界知识产权组织版权金奖(中国)颁出

On June 11th, the 4th WIPO Copyright Gold Awards (China) Ceremony was held in Xiamen, Fujian. 6 work awards, 4 promotion and use awards and 4 protection awards were handed out.

Reporters learned that, the novel "Red Sorghum" by Mo Yan, video works "Tongue of China I" by CCTV Document Channel, "Laughing Cat Diary" series by Yang Hongying, "Song of Seven Cities" by Li Haiying (composer), artwork "Four Great Classics" by Tianjin Shenjie Cartoon Co., Ltd., literary works "One Hundred Thousand Whys" by Children's Publishing House were awarded the Work

Awards. Four companies got the Promotion and Use Awards, including Beijing iQIYI Science and Technology Ltd., Beijing iReader Science and Technology Ltd., Shanghai Wu'an Communications Ltd. and Qingdao Publishing Group Ltd. Protection Awards were issued to novel writer Zhang Kangkang, Anhui Province Public Security Bureau, Xiamen City Meiya Information Co., Ltd. and China Film Co., Ltd.

According to reports, the WIPO Copyright Gold Awards is a global award mechanism established in the field of copyright by WIPO, and nearly 70 countries and regions participate

in. Since the beginning of 2008, China's National Copyright Administration introduced this award to China in cooperation with WIPO.

本报讯 6月11日,第四届世界知识产权组织版权金奖(中国)颁奖仪式在福建厦门举行,共颁出了6个作品奖、4个推广运用奖和4个保护奖。

据了解,此次获得作品奖的作品有莫言小说《红高粱》、中央电视台纪录频道制作的影视作品《舌尖上的中国1》、杨红樱创作的作品《笑猫日记》系列、李海鹰(作曲)创作的音乐作品《七子之歌》、天津神界漫画有限公司创作的美术作品《四大名著》、少年儿

童出版社推出的文字作品《十万个为什么》;获得推广运用奖的企业有北京爱奇艺科技有限公司、北京掌阅科技有限公司、上海五岸传播有限公司、青岛出版集团有限公司;获得保护奖的个人和单位则包括张抗抗、安徽省公安厅、厦门市美亚柏科信息股份有限公司、中国电影股份有限公司。

据介绍,世界知识产权组织版权金奖是世界知识产权组织(WIPO)在版权领域设立的全球表彰机制,目前已有近70个国家和地区加入其中。自2008年始,中国国家版权局与WIPO合作将这一奖项引入中国,开展版权金奖的评选表彰活动。(姜新穎)

Nexus trademark case to be on trial "nexus"商标行政案将开庭审理

When searching "nexus" in Baidu or Google, almost all of the information points to Google's mobile phone brand "nexus". The mobile phone of Google is marked "nexus" trademark in the United States, but is marked "Motorola" trademark in China. On one hand, Motorola's mobile phone business belongs to Google, on the other hand, Google failed to register "nexus" trademark on the phone in China, while the trademark was owned by Beijing Ruifengda Trade Co., Ltd. Recently, Beijing Intellectual Property Court received the administrative disputes caused by nexus trademark.

Ruifengda applied "nexus" trademark on mobile phones and other goods in 2007. A natural person named Wang Qinghua submitted the revocation application against "nexus" to Trademark Office under the State Administration for Industry and Commerce of China in January 13th,

2011, acclaiming that Ruifengda's lack of using the "nexus" trademark for three years. The Trademark Office revoked the trademark. Ruifengda then applied for a review to the Trademark Review and Adjudication Board (hereinafter as TRAB) under the State Administration for Industry and Commerce. TRAB held that, the evidence provided by Ruifengda can prove it using the "nexus" trademark on mobile phones and other commodities from January 14th, 2008 to January 13th, 2011, and deciding to maintain its registration for "nexus" trademark on sets of wireless phones, car navigation equipment (vehicle computer) and mobile phones.

Wang Qinghua then filed the administrative lawsuit to the Court. The case will be on trial soon.

本报讯 在百度或者谷歌搜索引擎中输入"nexus"进行查询,几乎所有的信息都指向谷歌的手机品牌



"nexus".谷歌公司同一款手机,在美国标注"nexus"商标,但在中国却使用的是"摩托罗拉"商标。原因一方面在于谷歌公司收购了摩托罗拉手机业务,另一方面则是谷歌公司在中国并未能在手机等商品上拥有"nexus"商标,该商标的注册人为北京瑞丰通达贸易有限公司(下称瑞丰通达公司)。日前,北京知识产权法院受理了因"nexus"商标产生的行政纠纷案件。

在手机领域名不见经传的瑞丰通达公司,于2004年在手提电话等商品上申请注册了"nexus"商标,并于2007年获准注册。针对瑞丰通达公司的"nexus"商标,自然人王清华于2011年1月13日向国家工商行政管理总局商标局提出撤销申请,认为瑞丰通达公司注册的"nexus"商标此前三年未予使用,应予撤销。商标局

经审查撤销了该商标。瑞丰通达公司不服商标局所作决定,向国家工商行政管理总局商标评审委员会提出复审。商标评审委员会经复审认为,瑞丰通达公司提供的证据可以证明其于2008年1月14日至2011年1月13日在手机等商品上使用了"nexus"商标,并决定对"nexus"商标在成套无线电话、车辆导航仪器(随车计算机)、手提电话商品上的注册予以维持。

王清华不服商标评审委员会的决定,向北京知识产权法院提起了行政诉讼。据悉,这起案件将于近期在北京知识产权法院开庭审理。
