### Vice Premier: China encourages fair competition among enterprises

## 中国政府鼓励企业公平竞争competition

he 2nd BRICS International Competition Conference was held in Beijing on September 21. At the opening ceremony, Chinese Vice Premier Wang Qishan stressed that BRICS countries should communicate with each other closely to boost cooperation with other countries as well as international organizations in terms of enforcing competition law. Enterprises competing fairly in China were encouraged while those behaving unfairly would be punished, he added.

In a bid to create a legal en-

vironment in favor of competition, with legislation of laws governing unfair competition, protecting consumer rights and interests and IPR, China has basically cleared obstacles and established the legal system regulating a full range of enforcing law. Starting from October 2010, China has achieved palpable results in a nationwide campaign on combating IPR violations and on the production and distribution of fake and shoddy products.

王岐山说,为了营造公平竞争的法制环境,中国制定出台了反不正当竞争法、消费者权益保护法、知识产权法等一系列法律法规,建立和完善竞争执法体制,坚决破除妨碍公平竞争的各种障碍。去年10月以来,中国政府开展了打击侵犯知识产权和制售假冒伪劣商品专项行动,成果显著。

Taobao shop under indictment for distributing fake HELLO KITTY

### 淘宝店主销售假冒 "HELLO KITTY"商品被公诉

hanghai Pudong District People's Court recently took the prosecuting authority's complaint on Gu and Zhang's infringement of "HELLO KITTY" trademark.

The prosecuting authority filed a case with the court, asserting Gu and Zhang's distribution of counterfeit HELLO KITTY on the website of TAOBAO with a total of 800,000 yuan in revenue, during the period from July 2009 to December 2010. On December 28,2010, Shanghai Pudong Public Security Bureau seized over 70 kinds of fake products worth 110,000 yuan which infringing trademark of SANRIO company.

The plantiff held the defendants's distribution of counterfeit products is on purpose and should be prosecuted for criminal liability.

As of nows, the court has not yet rendered a ruling. We will fol-

海市浦东新区人民法院提起一起因在淘宝网上销售假冒"HELLO KIT-TY"商品涉嫌构成销售假冒注册商标商品罪的知识产权刑事案件。 据了解,2009年7月至2010年

据了解,2009年7月至2010年12月期间,被告人顾某、张某为牟取非法利益,在淘宝网站上开设"娟子家的凯蒂"网店,销售假冒三丽鸥股份有限公司"HELLO KITTY"品牌的各类商品,销售金额共计80万余元。2010年12月28日,上海市公安局浦东分局抓获俩被告人,并当场查获70余种假冒"HELLO KITTY"品牌的商品,货值金额为11万余元。经鉴定,上述查获物品均为侵犯三丽鸥股份有限公司注册商标的商品。

公诉机关认为,俩被告人销售明知是假冒注册商标的商品,数额巨大,应当以销售假冒注册商标商品罪追究其刑事责任。目前,该案正在进一步审理中。

oordination Bureau under the Ministry of Industry and Information Technology and the Institute of Industrial Economics Chinese Academy of Social Sciences jointly issued released the Summer 2011 report on China Industrial Economic Situation. In this year, the national economy towards the expected direction of macro regulation and control, industrial production showed the economy running smoothly, continue to improve efficiency and structure a

good pattern of steadily adjusted.

As result of serious shortage of technological innovation and R & D investment, the majority of our industries and enterprises do not own the core technology, IPR and self-brands, China should increase policy support for technological transformation and accelerate the use of advanced practical tech-

nologies and high technology to transform and upgrade traditional industries, lack of independent innovation capability as soon as possible to change the passive situation.

The two sides also signed the Cooperation Framework Agreement on Establishing Patent Examination Assistance Center in Guangdong.

According to the agreement, the center would become the first

### Chinese Patent Award candidates out for public scrutiny

### 第十三届中国专利奖评审结果接受公众监督

fter intense examination and vote, the result of the 13th Chinese Patent Award is announced on the website of SIPO and China Intellectual Property News for public comment from September 14 to 28. The 233 patent projects announced include 15 patent gold medals and 5 design gold medals, 178 and 35 excellence projects for patent and design respectively.

The competition has received a total of 697 entries including 517 invention projects, 70 utility model projects and 110 design projects. Among the participating patents, 379 are recommended by local IP administrations, 164 are recommended by ministries, 70 are recommended by fellows of science or engineering academies and 84 are recommended by industry associations. After selected by a jury, 585 are in the next round of evaluation.

(by Liu Shan) 本报讯 9月14日至28日, 备受关注的第十三届中国专利奖评 审结果在中国国家知识产权局网站 和《中国知识产权报》公示(详见本 报9月14日第12版到第15版), 并接受社会公众监督。此次公示项目共 233 项,包括 15 项中国专利金奖项目、5 项中国外观设计金奖项目、178 项中国专利优秀奖项目及35 项中国外观设计优秀奖项目。

据介绍,第十三届中国专利奖 共收到申报项目 697 项,其中发明 专利项目 517 项,实用新型专利项 目 70 项,外观设计专利项目 110 项;按推荐类别划分,地方知识产权 局推荐 379 项,部委推荐 164 项,两 院院士推荐 70 项,行业协会推荐 84 项。经中国专利奖评审办公室初步 审核,共计 585 项初审合格项目进 人评审环节。
