Sichuan, Anhui and Tianjin followed suit from fourth to tenth. The top 3 provinces for invention patent granted are Guangdong, Beijing and Jiangsu with 9,038, 7,470, and 5,058 respectively, Sichuan climbed to the eighth from ninth over last year with 1,528, up 49.28%. (by Li Qun)

Two men behind bar for distributing counterfeit GUCCI suitcases

两案犯销售 假冒 GUCCI 箱包终审获刑

People's Court recently rendered a final judgement on distributing counterfeit GUCCI suitcase. Two defendants surnamed Song and Cai were sentenced to two years and one year imprisonment respectively along with fines of 150,000 yuan for each of them.

Song and Cai have begun distributing counterfeit GUCCI suitcase in Beijing since 2010. After receiving a tip on their activity, Beijing police seized 2,500+ counterfeit GUCCI suitcase with a total value of 300,000 yuan in a Chaoyang District location and arrested the suspects.

The court held that the two defandants knowingly distributed bags with counterfeit registered trademark and the amount of proceeds involved was significant, crime was constituted. So ordered.

本报讯 日前,两无业人员宋某、蔡某涉嫌销售假冒"GUCCI"注册商标商品被提起公诉。据悉,北京市第二中级人民法院终审裁定:驳回其上诉,维持一审法院的判决,即以销售假冒注册商标的商品罪分别判处宋某2年有期徒刑,罚金15万元;判处蔡某1年有期徒刑,罚金15万元。

据悉,2010年起宋某、蔡某开始在北京销售假冒 GUCCI 品牌的商品。2011年初,警方接到报案称在朝阳区某地有人出售假冒 GUCCI包,根据举报线索公安机关对朝阳区某处进行搜查,当场起获2500余个 GUCCI箱包,抓获宋某和蔡某。经鉴定,起获的箱包均为假冒"GUCCI"商标的商品,案值30余万元。

北京市第二中级人民法院经审 理认为,宋某、蔡某明知是假冒注册 商标的商品仍予以销售,货值金额巨 大,其行为均已构成销售假冒注册商 标的商品罪,依法应予惩处。据此,法 院作出上述裁定。

AICs enforcement campaign delivers

中国工商系统专项行动成效显著

hina's administration for industry and commerce (AICs) on July 28 announced their fruitful output since China launched the national campaign on combating IPR violations and on the production and distribution of fake and shoddy products. As of June 30, AICs have totally handled 90,701 infringement cases with a total value of 510 million yuan. Of all the cases handled, 13,831 relating to well-known trademarks, 13,179 648 involving foreign trademarks and GIs, respectively.

During the campaign, AICs have mobilized 3.978 million law enforcement officers/times to examine 9.226 million businesses, 1,745 illicit dens were banned. Among the cases, 90,701 of which were brought on file and 757 were transferred to judicial organs.

IP CHINA'S IP MANUAL

Medium and Long-Term Plan on Developing High - Skilled Talent (2010-2020)

《高技能人才队伍建设中长期规划(2010年-2020年)》

日前,中央组织部、人力资源社会保障部发布《高技能人才队伍建设中长期规划(2010年-2020年)》(以下简称《规划》),这是中国首个高技能人才队伍发展规划。

《规划》明确提出,到 2015年,拥有特殊操作法或技能革新、发明专利的高技能人才占所在单位高技能人才的比例不低于 50%;到 2020年,拥有特殊操作法或技能革新、发明专利的高技能人才占所在单位高技能人才的比例不低于 80%。《规划》还指出中国高技能人才队伍建设的主要任务,包括营造有利于高技能人才成长的社会氛围、健全高技能人才评价体系以及构建有效的高技能人才使用机制等。

The Organization Department of the Central Committee and Ministry of Human Resources and Social Security jointly issued a Medium and Long-Term Plan on Developing High-Skilled Talent (2010-2020) recently, which is the first plan of its kind in China.

According to the plan, by 2015, the proportion of talent with special maneuver or having ability to practice technical innovation and obtain invention patents shall account for at least 50% in the work unit. By 2020, this number shall stand at least 80%. The plan also contains the main tasks to achieve the goal, that is, creating a good social atmosphere for the high-skilled talents, perfecting training system as well as developing a high-efficient mechanism for the talent.

Patent right pledge financing amounts to 31.85 billion yuan

ome 3,361 projects had secured the loan of 31.85 billion yuan (including equivalents of foreign currency) from January 2006 to June 2011, providing a strong support for the SMEs development, sources from SIPO said recently.

A representative from the Patent Administration Department of SIPO said that SIPO has launched IPR pledge financing pilot projects in nearly 20 areas in

China. Some 400 SMEs secured a loan of more than 3 billion yuan in 2010, licensing contract record of the pledge has increased for 5 consecutive years with annual growth rate of 70% in pledge financing amount.
