According to a survey over 22 plant agricultural products by the State Administration for Industry and Commerce, prices of agricultural products hike drastically after registration of geographical indications (GIs), up 306% on average with the highest at 2,900%.

18.33 billion

According to the General Press and Publication Administration, the sales revenue of the online gaming market in China scored 18.33 billion yuan in 2008, up 76.6% over 2007. Online gaming also brought 47.84 billion yuan to telecommunication and IT industry.

As of the end of 2008, Yunnan owned 36 new flower varieties, ranking No.1 in the nation. In parallel, 70% of new varieties of fresh flowers were from the province, supporting an industry with the size of 17.6 billion yuan. The seeds of these IPR-boosting flowers were exported for the first time.

WTO rejects most U.S. complaints on China IPR protection

中美知识产权 WTO 争端案终结

专家组报告驳回美方绝大部分主张,肯定中国知识产权制度

he World Trade Organization (WTO) rejected most U.S. complaints about IPR protection in China on March 20, concluding the two year strife between the two trade powers.

The dispute involved three measures in contention. The panel rendered rulings to all of them. In terms of criminal threshold, the panel held U.S. fails to prove that China's criminal threshold is inconsistent with the Agreement on Trade Related Aspects of Intellectual Property Rights (TRIPS). In terms of custom measures, though the practice of mere removal of illegal labels from imported counterfeit goods is inconsistent with TRIPS, U.S. fails to

prove that donation to social services or sales to right holders is inconsistent with TRIPS. U.S. also fails to prove that Chinese legal provisions on auction impacts customs' power on destroying goods. In terms of copyright law, the panel held that U. S. fails to prove that Chinese practice in not protecting works that never submits for approval, pends for approval and does not change according to approval, is inconsistent

据悉,中美知识产权 WTO 争端 案共涉及3项争议措施,专家组的 裁决结果是:关于刑事门槛,专家组 裁定美国没能证明中国有关刑事门 槛的规定不符合 WTO《与贸易有关 的知识产权协议》(TRIPs 协议);关 于海关措施,专家组认为,虽然海关 对进口冒牌货仅摘除非法标志的处 置方式不符合 TRIPs 协议,但美国 没能证明捐赠给社会公益机构、卖 给权利人等处置方式不符合 TRIPs 协议,美国也没能证明中国有关拍 卖的规定影响了海关销毁货物的权 力;关于著作权法,专家组认为,美 国未能证明从未提交审查的作品、 在等待审查结果的作品、通过审查 作品之未修改版本等不符合 TRIPs 协议。 (张海志 薛 飞)

he inter-agency meeting secretariat for implementation of the national IPR strategy announced the National IPR Strategy Implementation Plan

The Plan was divided into two parts, including working requirements of this year's IPR strategy implementation work and the specific measures. The working requirements cover enhancing IPR legal situation, administrative management capacity and publicity and education. And the specific measures with 240 items range from promoting IPR creative ability, enutilization, quickening IPR legal system construction and elevating IPR law enforcement level to developing IPR agent service, impelling IPR cultural construction, enlarging foreign exchange and co-

ccording to SIPO, the nationwide toll-free number to assist IPR right enforcement 12330 will be in play on April 25 during the national IPR publicity week.

In November 2008, SIPO applied for the use of the number to the Ministry of Industry and Information Technology (MIIT), which would approve on January 20, 2009. The right enforcement assistance centers using the number are to take tips or complaints on IPR infringement and other violation

from any organization or individual directly and those tips or complaints transferred from other agencies. After taking them, the center will distribute the cases to responsible IPR administrative enforcement agencies or police and convey the results to informants or complaints. (by Yang Jia/Ji Jie)

Chinese batteries prevail marathon 337 investigation

中国电池企业赢得337调查最终胜利

he Supreme Court of the United States rejected the reexamination petition of battery giant Energizer and its subsidiary Eveready over Court of Appeals for the Federal Circuit (CAFC) decision in invalidating its patent for zero-mercury-added alkaline batteries, upholding the ruling of the International Trade Commission (ITC) which decided the inval ity of patent right of Energizer's zero-mercury-added alkaline batteries, and terminated the 337 investigation.

On April 28, 2003, Energizer Holdings, Inc. claimed that nine Chinese manufacturers of zero-mercury-added alkaline batteries, and two dozens of American and Japanese companies, infringed its U.S. Patent No. 5,464,709 patent (the "709 patent"). Energizer then filed a complaint with the International Trade Commission (ITC) in the U.S. to conduct a Section 337 investigation on their claims.

In October 2004, ITC terminated the investigation by declaring the patent invalid in its final determination. After that, Energizer appealed 4 times in total. In October 2008, CAFC made its

final decision, declaring the 709 patent invalid. Energizer then appealed again to the Supreme Court of the Unite States. On March 23, 2009, the Supreme Court denied the petition and upheld the CAFC decision. (by Zhuo Ma/Liu Peng)

本报讯 美国当地时间3月 23日,美国联邦最高法院驳回了美国 劲量公司及其附属公司永备电池公司 要求对美国联邦巡回上诉法院做出的 无汞碱锰电池专利权无效的裁定进行 复审的请求,维持了美国联邦最高法 院的终审判决, 即维持美国国际贸易 委员会(ITC)裁定,判决劲量公司无汞 碱锰电池专利权无效,终止337调查。

2003年4月28日,劲量公司和永 备公司以侵犯了其无汞碱锰电池专利权 为由,将中国的南孚、双鹿、虎头、长虹、 高力、豹王、正龙、金力、三特9家企业及 其他20多家美国、日本企业一举诉上 ITC,要求ITC就此展开337调查。

2004年10月,ITC终裁裁定原 告专利权无效,并终止调查。此后,劲 量公司和永备公司共提出4次上诉。 2008年10月,美国联邦巡回上诉法 院做出终审判决。之后, 劲量公司向 美国联邦最高法院提起上诉。2009年 3月23日,美国联邦最高法院驳回 了劲量公司和永备公司的复审请求, 从而维持了美国联邦巡回上诉法院 (卓玛 柳鹏)

State Council Opinions on Implementing Allocation of Key Duties Prescribed in the Report of the Work of the Government

n March 22, the State Council announced its Opinions on Implementing Allocation of Key Duties Prescribed in the Report of the Work of the Government, including continue implementing IPR strategy into the key duties of the year and appointing SIPO as the commanding agency.

The fourth part of the Opinions, accelerate transformation of development methods and promote strategic adjustment of economic structure, pronounces several IPR-related tasks: continue implementing IPR strategy, refine IPR legislations, enhance construction of IPR public service system, increase quality and efficiency of IPR examination, con-

tinue campaigns of IPR protection, intensify public education, promote international communication and cooperation.

3月22日,《国务院关于落实< 政府工作报告 > 重点工作部门分工 的意见》(以下简称(《意见》)发布。 《意见》将"继续实施知识产权战略" 列入今年的重点工作,并明确该项工 作由国家知识产权局牵头。

《意见》在第四部分"加快转变发 展方式,大力推进经济结构战略性调 整"中明确,继续实施知识产权战略。 完善知识产权法律法规体系;加强知 识产权公共服务体系建设,提高知识 产权审查质量和效率;继续开展保护 知识产权专项行动。加大知识产权宣 传教育力度;推进知识产权对外交流 与合作。
