Hong Kong: 10 years after return, unique & proud IPR system

回归 10 年香港知识产权事业更加璀璨

n early June, days before the 10th anniversary of Hong Kong's return to motherland, our China Intellectual Property News reporters interviewed Director Stephen Selby, Hong Kong Intellectual Property Department (HKIPD) at his office. Selby said that a unique and fully functional IPR system has been nurtured in Hong Kong since its handover. The IPR system is running in the right groove which gives rise to

effective IPR protector.

Selby guided us in a decade journey encompassing the evolution of Hong Kong's IPR legislations, IPR enforcement and public education. According to the statistic, HKIPD has been seeing across-the-board hikes in filings and registrations of trademark, patent and design in the past 10 years. The numbers for filings and registrations of trademark for 1997 were 18. 529 and 12,680. In 2006, they



jumped to 22,994 and 17,907. In the category of standard patent, the numbers for filings and grants for 1997 were mere three digits, 842 and 147. Those figures leapfrogged to 13,790 and 5,147 in 2006. Getting itself on the full alert for possible infringements of Olympic IPRs in Hong Kong, HKIPD set up a special unit dealing with the subject.

采访中,谢肃方就香港知识产 权法律法规的演变、知识产权现状 及知识产权宣传等做了介绍。据统 计,10年来,香港知识产权署受理商 标、专利、外观设计申请和注册数目 大幅度增长。在商标方面,1997年香 港商标申请数目为 1.8529 万件 ,注 册数目为 1.268 万件。 2006 年香港 商标申请 2.2994 万件,注册 1.7907 万件。在专利方面,1997年标准专利 申请 842 件,获权 147 件,到 2006 年,标准专利申请1.379万件,获权 5147件。目前,香港知识产权署还成 立了奥林匹克知识产权管理小组, 以提防在港发生侵犯奥林匹克知识 产权的事件。

48 antidumping investigations of imported goods conducted by China so far

ice Minister for Commerce Gao Hucheng informed the participants attending the International Seminar on the 10th Anniversary of China's Antidumping Legislation and Practice on June 25, China conducted 48 antidumping investigations of imported goods, making a good use of international common rules to develop and protect domestic industries.

"Under the new situation of positively undertaking measures on expanding export, we will properly conduct relationship between export expansion and maintaining of domestic industries' development. China will strictly abide by WTO regulations and domestic laws and rules, avoid misuse of anti-dumping measures in practice, so as to truly represent the trade remedy essence of antidumping measures on curbing unfair competition and maintaining fair trading order, "added Gao.

Actions, SigmaTel settle patent disputes

ctions Semiconductor has settled all outstanding litigation worldwide with the US MP3 chipmaker SigmaTel, ending their 3 year patent lawsuits in a peaceful manner, the Zhuhai-based corporation told our reporter recently.

Under terms of the settlement agreement, all outstanding claims and counterclaims in the lawsuits in which the two companies have been engaged will be dismissed. Both companies also agreed to not pursue possible third party IP infringements or new legal actions against each other and their respective customers for three years. Additionally, Actions and SigmaTel entered into a comprehensive cross-license agreement. "Actions has only less than 10% share in the US market. After the settlement, the US market is becoming our development priority, " an Actions PR principal told our CIPN

Gls registered in China

251 件地理标志商标在中国获得注册

t the International Symposium on Geographical Indications (GI), an event co-organized by the State Administration for Industry and Commerce (SAIC) and the World Intellectual Property Organization (WIPO) on June 26, SAIC Vice Minister Li Dongshen announced China has made use of the trademark system to protect GI, an important type of IPR. A total of 251 GIs have been registered under that

Li said, any qualifying GI holder may file an application to the Trademark Office of the SAIC through trademark registration proceeding. He will acquire an exclusive right to that GI once the application is approved. That right can also facilitate registration in many other countries through the international agreements China has acceded to.

Li also reminded the participants of GI enforcement, Administrations for Industry and Commerce of all layers have run more frequent checks of GI infringements and brought nearly 300 cases.

李东生说,地理标志所有人只 要符合注册条件,按照商标申请注 册程序向国家工商行政管理总局商 标局提出申请并经过审查,即可获 得地理标志专用权。借助于中国参 加的国际公约,可以便利地在其他 国家注册。

李东生说,各级工商部门不断 加强对地理标志的保护,查处了侵 犯地理标志案件近300件。

Basic Information of National Press and Publishing Industry 2006

2006 年全国新闻出版业基本情况》

he Planning and Finance Department of the General Administration of Press and Publication recently released a statistics report, namely Basic Information of National Press and Publishing Industry 2006 (statistics of Hong Kong, Macao and Taiwan Province not included).

In 2006, magazines and newspapers maintained a steady momentum. A total of 9,468 titles of magazines (same as the previous year) published 2.852 billion copies, a 3.38% increase. A total of 1,938 titles of newspapers (0.36% increase) published 42.452 billion copies, a 2.89% increase.

The copyright administrations of all layers nationwide in 2006 handled

10,559 cases and concluded 10,344, marking 98% conclusion rate. Among the concluded cases, 8,524 were concluded with fines imposed; 1,585 settled; and 235 transferred to judicial The administrations authorities. seized a grand total of 73.69 million pirated copies of various kinds of publications in 2006, 18.37 million of which were books, 1.11 million magazines, 48.14 million AV products, 2.02 million e-publications, 3.8 milsoftware and 250,000 other
